Some certificate of competence (CoC) holders have been unable to complete the continuing professional development (CPD) required to renew their CoC due to COVID-19 and its impact.

If you're in this situation, you can use this form to ask WorkSafe for an exemption that would allow your renewal application to be considered without having to complete the CPD requirements in full.

This application is for an exemption from Regulation 43 of the Health and Safety at Work (Mining Operations and Quarrying Operations) Regulations 2016.

To be considered for an exemption, applicants are expected to:

- Have completed at least 80% of the CPD requirements applying to their CoC.
- Have been unable to complete the remainder of the CPD requirements due to the impacts of COVID-19. For example:
  - CPD events they were planning to do/attend were cancelled because of COVID-19 alert level restrictions
  - they or someone in their bubble has had COVID-19
  - they are at higher risk of the effects of COVID-19 and need to stay home, or
  - other extenuating circumstances directly related to effects of COVID-19 and alert level restrictions.
- · Provide all the information required to support their exemption application.

In addition, the New Zealand Mining Board of Examiners must confirm the applicant meets all other requirements for the renewal of their CoC.

WorkSafe will consider exemption requests on this basis, and in accordance with section 220 of the Health and Safety at Work Act 2015, from CoC holders whose CoC renewal is due between 1 May 2020 and 31 December 2021.
