

Application for a determination on a reduction in separation from packages of class 6 or 8 substances

This form must be used to apply for a determination under regulation 13.43A of the Health and Safety at Work (Hazardous Substances) Regulations 2017 (the Regulations). The determination relates to the reduction of the separation distances prescribed in regulations 13.41 and 13.43 of the Regulations between an onsite protected place and a hazardous substance location holding packages (see note 1) of class 6 and/or 8 substances.

If a class 6 substance also has a class 2 or 3 classification, the applicable separation distances are those for the class 2 or 3 classification not the class 6. If the substances are held in stationary tanks, then a determination from WorkSafe to reduce the separation distance is not required. The separation distances for tanks of class 6 and 8 substances are outlined in Part 17 of the Regulations (see note 2).

5. Notes

- Packaging means one or more containers in which a substance may be encased, covered, enclosed, contained or packed, and any other components or materials necessary for the containers to perform their containment and other safety functions.
 - For the purposes of regulation 13.43A this includes small containers, drums, and IBCs but does include stationary containers.
- If substances are held in stationary containers, the separation distances set in regulation 17.28 and 17.29 may also be reduced to onsite protected places subject to appropriate risk assessment and control as provided in the AS/NZS standards AS/NZS 4452:1997 The storage and handling of toxic substances and AS 3780: 2008 The storage and handling of corrosive substances.
- 3. A hazardous substance location (HSL), in relation to a class 6 or 8 substance, means an area where a quantity of the substance exceeds the relevant quantity specified in regulation 13.38 is located for more than 24 hours (or 2 hours if the substance is subject to tracking provisions). An HSL does not include a vehicle, a ship, or an aircraft while it remains under the direct control of its driver, master, or pilot and under the jurisdiction of the Land Transport Rules, the Maritime Rules, or the Civil Aviation Rules (as the case may be); or a transit depot.
- 4. A protected place is defined in the HS Regulations as: [A protected place]
 - a. includes:
 - i. a dwelling, residential building, place of worship, public building, school or college, hospital, child care facility, or theatre, or any building or open area in which persons are accustomed to assemble in large numbers, whether within or outside the property boundary of a place where a hazardous substance location is situated:
 - ii. any factory, workshop, office, store, warehouse, shop, or building where persons are regularly employed, whether within or outside the property boundary of a place where a hazardous substance location is situated:
 - iii. a ship lying at permanent berthing facilities:
 - iv. a public railway; but
 - b. does not include a small office or other small building associated with a place where storage, handling, use, manufacture, or disposal of a class 2, 3, 4, 5, 6, or 8 substance is a major function.
- 5. It is the responsibility of the applicant to propose and identify the actions (control measures) that mitigate the risks associated with the reduced separation. These alternative control measures cannot be matters that you are already required to comply with under the HS Regulations.
- 6. A compliance certifier who is engaged as part of this process must be authorised by WorkSafe to certify locations containing class 6 and 8 substances. The report they supply must have regard to their view on the following matters:
 - the location and operation of the protected place
 - the appropriateness of the proposed alternative controls
 - the extent to which minimum separation distances may be reduced.
- 7. Any matter that relates to certification or qualifications (such as workers training) must be supported by evidence.
- 8. The TST number is the WorkSafe authorisation number for the compliance certifier. You can ask the certifier for this number, or you can find it from the public register of authorised compliance certifiers: worksafe.govt.nz
